**Important League Information!!**

(1) In accordance with FVC Rule #19, work teams indicated on the schedule in (parenthesis) for matches that have a paid referee are recommended to provide a scorekeeper and two line judges for the indicated match. **Work teams are required to provide a minimum of two line judges with one keeping score.** When a line judge is keeping score they are required to hold the score flipper for safety purposes.

In accordance with FVC Rule #21, work teams indicated on the schedule in (parenthesis) for matches that have a team provided facilitator are recommended to provide a facilitator, a scorekeeper and two line judges for the indicated match. **Work teams are required to provide a minimum of a Facilitator and two line judges with one keeping score.** When a line judge is keeping score they are required to hold the score flipper for safety purposes.

The penalty for failing to supply a full work team is, at the Administrator's discretion, forfeit of one game and can be extended to three games for repeat and/or intentional offenses.

(2) If there are problems with referees or building directors, contact Rebecca Johannes - at [202-409-7006](tel:202-409-7006). **In the event that a ref is not present at match start time, it is the responsibility of the playing teams to start on time and the work team to provide a match facilitator to monitor the match.** Please notify the Club by emailing [administrator@fairfaxvolleyball.com](mailto:administrator@fairfaxvolleyball.com) of the no-show. Anyone who facilitates a match that was supposed to have a paid referee, can receive compensation for doing so by contacting the Administrator.

(3) Report win/loss to **Julie Leiloglou** at [julie.smock@gmail.com](mailto:julie.smock@gmail.com) within two (2) days of the match. All Team Representatives are required to report match results (win/loss) to the Division Representative within two days of the match. Both teams are to report regardless of win/loss record. Failure to report match results within the allotted time will result in three losses for the non-reporting team(s).
